President's Message

### Dear Fellow Members,

2012 has been a challenging year, with key financial events taking place in the United States, Europe, China, and the growth of Asian economies on a decline. Budget 2013 has resulted in tightening measures of foreign manpower as well as the introduction of a series of business schemes and subsidies to promote innovation and productivity.

The Singapore economy is going through restructuring to transit to a more sustainable model of productivity growth. At the sectoral level, the manufacturing industry must continue to move up into higher value-added activities, as manufacturing activities have evolved in complexity and are becoming more knowledge and innovation-intensive.

With the current global economic situation, companies need to proactively move and adapt to external changes. Championing the manufacturing sector in Singapore, Singapore Manufacturing Federation (SMF) also needs to respond quickly to these changes so as to best serve the needs of the industry, economy, community and the nation.

### **Transformation**

The manufacturing landscape is changing beyond the traditional production to high-value manufacturing, including "servitisation" of manufacturing. In order to also encompass SMF's services to companies providing services to manufacturers, the former Singapore Manufacturers' Federation (SMa) changed its name to Singapore Manufacturing Federation (SMF) on 29 September 2012. The SMF logo was also unveiled by Guest-of-Honour Prime Minister Lee Hsien Loong at SMF's 80th Anniversary Gala Dinner.

The launch of the Capacity and Capability Development Programme (CCDP) by SMF gives a holistic and comprehensive solution to companies. CCDP aims to create value in the supply chain of the manufacturing community, drive competitiveness and sustain growth by addressing the specific needs of the industry. Through the adoption of a systematic approach to business transformation, CCDP will help enterprises remain viable and competitive.

At SMF, we champion "innovation-led productivity growth". Through the Singapore Innovation and Productivity Institute (SiPi), one of our 6 Centres of Excellence, we provide businesses with productivity resources, customised roadmapping and coaching support to help them implement their specific productivity programmes. SiPi has helped companies attain manufacturing excellence through providing a one-stop solution to analyse and enhance business productivity.

Increasing productivity will enhance business competitiveness and improve productivity growth. SME Centre@SMF helps business grow and enhance their operations through advisory services on productivity and government schemes.

### Sustainability

Sustainability in the manufacturing sector requires continuous improvement and transformation to stay relevant. SMF provides holistic solutions and services to our stakeholders.

With the Government's re-employment legislation encouraging the re-employment of older workers beyond the age of 62, the SMF Centre for Corporate Learning (CCL) has the Silver Productivity programme in place. This is the first training programme of its kind, raising productivity for companies while enhancing the well-being of the older workers.

Through the Internship Programme, students enrolled at SMF Institute of Higher Learning (IHL) are given the opportunity to gain in-depth knowledge of the inner workings of an organisation and receive employment accreditation at the end of internship. The Maven series enable students to engage and learn from experts in the corporate world.

SMF Standards Development Organisation (SMF-SDO) has also seen 96 Standards launches, developments and reviews over the last two years, and a 200% increase in volunteers to 526 volunteers. Through implementing standards, it will ensure the high quality of Singapore products and services.

### **Partnership**

To enhance the competitiveness of companies through exploring new markets and business opportunities, the SMF Global Business Groups (GBG) launched the Business Expansion Programme to assist companies interested in Iskandar Malaysia and Riau Indonesia to provide information and to facilitate companies to access networks in the two countries.

SMF organised a series of talks and dialogue sessions with ministers and government agencies, engaging our members and allowing them to have a better understanding of the government schemes and views. Furthermore, our Centres of Excellence such as GS1 and SME Centre@SMF, as well as our Function Committees such as Membership & Industry Groups and Global Business Groups have been very active in helping our members to improve their business and explore new business opportunities overseas.

We are committed to creating and adding value to our members and the industry. 2013 will see more initiatives from SMF. To tackle the tight foreign labour measures, SMF will partner with SPRING Singapore to offer SMEs the SME Talent Programme (STP), where participating SMEs will receive assistance to attract local talents from the polytechnics and Institute of Technical Education.

Two Satellite Centres managed by SMF will also be launched at South West Community Development Council (CDC) and North West CDC. This will act as an extension of the SME Centre@SMF, which will expand our outreach to assist and advise more businesses in the South West and North West regions of Singapore.

I would like to thank you – members, partners and friends - for your membership and support through the past 12 months. I look forward to your continued support as SMF undertakes its mission as a national institution to champion the manufacturing sector in Singapore. Wishing all of you every success and happiness.



### SMF Corporate Structure 2012 - 2013



Leveraging on the strength of SMF's Industry Groups and Centres of Excellence, the CCDP identifies problems and proposes solutions, offering a holistic approach towards collaboration to improve productivity, competitiveness, skills upgrading and capitalising on new technologies for MNCs and SMEs. CCDP's integrated solutions include Human Capital Development, Customer Service Experience, Product Development, Technology Development, Awareness & Outreach and Supply Chain Development.

### The 4 Phases of the Capacity & Capability Development Programme (CCDP)

In Phase 1, CCDP identifies current gaps within the market and provides Capacity & Capability Diagnosis to large companies as well as SMEs and their value-chain partners. This diagnosis covers Productivity Processes, Productivity Improvement, Productivity Benchmarking, Business Model Innovation, Human Resource Development and Organisational Cultural Alignment.

Following the diagnosis, CCDP recommends Formal & Informal Executive Learning Programmes in Phase 2. This includes Workforce Skills Qualifications (WSQ) training programmes funded by the government for Executive and Academic Education.

In Phase 3, CCDP enables organisations to achieve Consultancy, Coaching Workshops & Solutions. This is carried out through an In-depth Productivity Consultancy, Human Resource Consultancy, Supply Chain Solutions, Certified Productivity & Innovation Manager (CPIM) Programme, the Quality Initiatives to Assist, Nurture, Grow (QIANG) Programme and Roadmap to Accelerate and Manage Productivity (RAMP). For other consultancy requirements such as branding, financial analysis and business excellence, the SME Centre@SMF provides these services.

Once the three phases have been implemented, in Phase 4, CCDP promotes the set-up of in-house Capacity and Capability Development centres which may include the centre for Virtual Learning, training, competency and knowledge or academic as well as a WSQ Approved Training Organisation (ATO). CCDP allows for customisation of curriculum to suit the needs of individual companies and the training of customers, staff and suppliers. Such centres can help to boost the branding of the organisation.

## Global Business Groups

The Global Business Groups (GBG) play an important role in helping the Federation's members to promote and expand their business in Singapore and globally. GBG proactively identify business opportunities for companies and create networking platforms and initiatives to assist companies to tap on market opportunities worldwide. GBG also assist members in enhancing their international competitiveness and branding by organising country conferences, regional seminars, workshops and other industry-specific educational and outreach programmes to train and upgrade the capabilities of members. From January 2012 to March 2013, GBG organised 45 Singapore Pavilions in leading trade exhibitions both locally and overseas, received over 50 incoming business visitors and delegations for networking and business matching, as well as organised several business delegations to various countries.

Singapore Manufacturing Federation (SMF) and Health Promotion Board (HPB) Workplace Wellness Programme Memorandum of Understanding (MOU)

A Memorandum of Understanding (MOU) was signed at Singapore HEALTH Award 2012 by SMF representatives Mr Michael Chin, Deputy President, SMF, and Mr Birch Sio, Chairman, HSSE Function Committee, with Mr Ang Hak Seng, CEO, HPB, on 30 November 2012. A following addendum to the MOU was signed on 8 February 2013 by Mr Lam Joon Khoi, Secretary-General, SMF, and Dr Annie Ling, Director of Adult Health Division, HPB. The Workplace Wellness Programme will see HPB working with SMF on a pilot model of mental wellness investment. Small groups of companies comprising mostly SMEs will collaborate to share consultancy services and wellness programmes from approved health consultants.

Workplace Safety and Health (WSH) Awards Convention for Manufacturing 2012

The WSH Awards Convention for Manufacturing 2012 was held at SPRING Auditorium on 30 May 2012 with more than 100 participants attending the event. A pool of safety innovation projects were received from the various manufacturing industries. 9 winning teams were chosen to present their projects to the panel of judges from SMF, Workplace Safety and Health Council (WSHC) and Ministry of Manpower (MOM) to compete for the "Gold", "Silver" and "Bronze" awards. The event was sponsored by Nexus Quest.

The 3 "Gold" Award winning teams received their "Gold" awards at the National WSH Awards Convention, organised by Workplace Safety and Health Council, on 17 July 2012.

### **Bukit Batok Nature Walk**

The Bukit Batok Nature Walk was organised to promote health and well-being amongst management and staff from manufacturing companies and related groups. On 16 June 2012, more than 80 participants from various companies such as Makino Asia, Symrise, Interplex and Seacare, and their family members participated in the 2-hour morning walk through the nature reserve. ### Launch of TR 32:2012

SMF-SDO and Ministry of Culture, Community and Youth (MCCY) jointly launched the Technical Reference (TR) on Recreational Diving "TR 32:2012" on 7 January 2013. TR 32:2012 was developed by the Recreational Diving Safety Committee (RDSC) under the National Water Safety Council (NWSC) and the Working Group under GESSC Technical Committee on Workplace Safety and Health. The launch was officiated by the Standards Council, SPRING Singapore and NWSC. The TR 32:2012 will serve as the common safety standard for recreational diving in Singapore. It includes regulations pertaining to the roles and responsibilities for participants involved in recreational diving, best practices for dive masters and diving instructors and the safety requirements for diving activities.

### **Food Standards Committee eXchange 2012**

The Food Standards eXchange 2012 was held on 6 November 2012 at Novotel Clarke Quay Hotel. 160 participants comprising Business Owners as well as Researchers, Professionals and Managers from more than 80 organisations attended the event.

The event showcased the benefits of adoption of standards to enhance food security, safety and traceability levels in Singapore through the promotion of food-related standards to food manufacturers, retailers and logistics operators.

### Industry Briefing for New Singapore Standard (SS) for Thermal Imagers for Human Temperature Screening

SiPi believes that it is important to improve productivity innovatively and develop innovation productively. As such, SiPi's current focus is on Business Model Innovation (BMI), which emphasises on changing the mindset, human resources, organisational development and the corporate culture of manufacturing companies in Singapore. Through addressing business model issues such as the heavy dependency on foreign labour and companies playing the middleman role with little value proposition, SiPi provides a holistic and customised package on innovation and productivity to advance manufacturing companies in Singapore.

Moreover, with strong benchmarking services and sharing of best practices, SiPi also serves as an education hub to raise awareness on productivity initiatives. This is further accomplished through outreach events such as conferences, seminars, dialogues and research studies.

## Singapore Innovation and Productivity Conference 2012 and Launch of SiPi

SiPi was launched by Guest-of-Honour Mr Lee Yi Shyan, Senior Minister of State for Trade and Industry & National Development, in conjunction with the Singapore Innovation and Productivity Conference 2012 on 30 October 2012. More than 300 participants attended the conference with a solid repertoire of international speakers from the innovation and productivity fields.

### Think-Tank Dialogue 2013

The interactive dialogue session on 23 January 2013, presented and facilitated by Mr Valerio Nannini, Chairman of the SiPi Board of Advisors, saw more than 40 participants attending the event. With the commencement of a new chapter celebrating an illustrious 80 years of history with a name change and a newly revamped logo, Singapore Manufacturing Federation (SMF) moved to its new home at Jalan Bukit Merah, known as SMF House, on 25 June 2012.
