New home for SMa School of Management





22 February 2007- Singapore Manufacturers' Federation (SMa) and Singapore Institute of Arbitrators (SIArb) signed a Memorandum of Understanding (MOU). The MOU was signed by Mr. Edwin Khew, President of SMa and Mr. Raymond Chan, President of SIArb.

Today's business, it is more than production, sales, marketing and managing resources like IT, human capital and financial resources. The stakeholders in the entire business chain and the manner in which business transactions are carried out are getting more diverse and complex. This is compounded further by cross-border and crosscultural differences

What is deemed expected and given in one setting could be totally unacceptable or out of the ordinary in another setting. Business practices and expectations vary over time as well as over space. Disputes arising from these differences are inevitable and common. The need for arbitration skills and knowledge become necessary and crucial. The ability to resolve any commercial or business disputes amicably and successfully will help pave the way for corporate sustainability and growth.

The aim of the MOU is to establish a new partnership for mutual collaboration in sharing expertise and efforts in the areas of education, training, promotion, arbitration and alternative dispute resolutions.

Easing The Challenges of Going Overseas

SMa and SFMa hoped that with the signing of the MOU, we can jointly develop and promote the Singapore food manufacturing industry and assist members to internationalise their businesses



SMa-WDA MOU To Promote Cooperation And Develop Manpower In The Manufacturing Industry

The Singapore Manufacturers' Federation (SMa) and the Singapore Workforce Development Agency (WDA) had signed a Memorandum of Understanding (MOU) to promote cooperation and develop manpower in the manufacturing industry, on 22 March 2007. The MOU was signed by President (SMa) Mr Edwin Khew and Chief Executive (WDA) Mr Ong Ye Kung at EDC Auditorium@SMa.

Under the MOU, SMa and WDA will collaborate with each other to develop manufacturing skills under the Singapore Workforce Qualifications (WSQ) System; to develop SMa as a manufacturing skills WSQ training provider; and to explore an avenue in establishing international benchmarking of WSQ manufacturing skills standards. This MOU will also enable SMa and WDA to cooperate with each other in industry development programmes, research activities, study trips and engagement with overseas organisations.

Said Mr Khew: "This MOU will advance training as one of the key thrusts of SMa's

strategic action plan to grow manufacturing and to attract manufacturing enterprises and start-ups into Singapore. Together with WDA, we will be better able to identify opportunities to develop our training and development capabilities, and to further the growth of Singapore's manufacturing sector."

Added Mr Ong: "The manufacturing sector in Singapore will continue to grow in output, value-add and employment. With a landscape that is constantly changing, it is inevitable that there will be new activities, new subsectors and new requirements for skills and expertise of workers. Despite these changes, WDA and SMa believe that there are many common skills that cut across manufacturing sub-sectors, such as quality control, safety, supply chain management, and continuous improvement. Hence, it will not be difficult to train a worker who has worked in a precision engineering company to become an aerospace technician. By the same token, it will not be hard for an assembly line operator, who has worked in an electronics firm, to adapt to similar work in a drug-making company. WDA and SMa want to collaborate, take stock of these common manufacturing competencies, and certify our manufacturing workers with these competencies, so that they can become resilient to structural unemployment."

WDA has recently established the Manufacturing Generic Skills Validation Committee to provide direction for WDA's Manufacturing WSQ Model. SMa has played an instrumental role in helping to provide input on the development of this model since January 2007. SMa also plans to come on board as a key WSQ training provider to deliver generic manufacturing WSQ courses, which are targeted to upgrade workers and move them up the value chain, and enable transferability of core skills across manufacturing sectors should there be a downturn in any particular sector.

With its focus on manpower development in the manufacturing industry, the MOU looks set to further enhance the competencies and grow the size of Singapore's base of over 500,000 workers in the industry.

ENGINEERING THE FUTURE:

EEPC COMMEMORATES ITS FIFTY

YEARS WITH INDIA ENGINEERING

MEET AND EXHIBITION

Message by Rakesh Shah, Chairman, EEPC

The Engineering Export Promotion Council (EEPC) represents the largest conglomerate of engineering exporters of India. Sixty percent of its members belong to the small and medium scale sector and have been instrumental in taking India's engineering exports from \$10 million in 1956/57 to \$20.3 billion in 2005/06, raising its export share from 0.5% in India's total exports in 1956/57 to 20% in 2005/06.

For the last 3 years, India's economy grew at an average of 8 per cent per annum and this growth was spearheaded to a significant extent by growth in the industry and services sector. India's manufacturing accounts of 16% of its GDP, while engineering accounts for 10-12% share of GDP. Engineering exports, on the other hand, account for around 3% of India's GDP and this makes the engineering segment a critical component of the India growth story.

It is with this economic backdrop that the EEPC organised the first ever India Engineering Meet and Exhibition (IEME) from January 22-24, 2007 at the India Expo Centre in Greater Noida, fifty kilometers from the capital city of India, New Delhi. The IEME coincided with the Golden Jubilee celebrations of EEPC aptly inaugurated by Hon'ble President of India, Dr. A.P.J. Abdul Kalam. The three day IEME mega event was attended by nearly 300 foreign buyers from ASEAN countries, Africa, USA, Canada, the European Union, Latin America and CIS countries and show cased a mammoth exhibition of capital goods, primary iron & steel and related items, consumer durables and other engineering products. Based on initial feedback from overseas delegates, the IEME was able to generate USD 20 million worth orders that have been booked

for outsourcing engineering goods from India while it is estimated that USD 70 million worth of enquiries were generated. 819 new contacts were made while 68 old contacts were revived for future business prospects. Thus, the IEME, which is the first ever Buyer-Seller Meet of this magnitude organized by EEPC was a grand success and from now will become an Annual Event for the Council.

It may, perhaps, be pertinent to note that the EEPC had brought out a Strategy Paper in 2005 with doubling exports by 2009/10 being one of its objectives. The ASEAN region had been identified as a thrust region in that Strategy Paper for engineering goods. The Strategy Paper suggests that in spite of tremendous potential of Indian goods in the ASEAN region, the Indian presence there is marginal. Despite the geographical proximity, India's engineering exports are just over 1% of the total ASEAN engineering imports from outside the block. However, the small volume of trade between India and ASEAN is hardly an indicator of its economic importance to India. What is more compelling is the fact that though the volume of trade is small, the trade basket has potential to move up the value chain and diversify to cater to the emerging and growing demand in the ASEAN countries. In fact, in the engineering sector, automobile parts and industrial castings have been identified as two major thrust products for the ASEAN region. To become successful in the ASEAN region, it may perhaps be important to leverage our existing institutional mechanisms and events like IEME can certainly go a long way in bringing the potential of India's engineering strength to the countries of ASEAN.

Engineering the Future is EEPC's

theme in the coming years. EEPC will have to work closely with our friends around the globe, more so with friends like Singapore Manufacturers Federation who took the initiative of sending a business delegation to New Delhi to participate in the first ever IEME. This is the beginning of our journey, of rebuilding our common bonds of cultural heritage and trade links with ASEAN countries. This is also in line with the "Look East" Policy of Indian Government that has given justifiable priority to developing ties with countries to our East, with whom there is considerable locational advantages of doing trade and commerce and enhancing people-to-people relationship. The Comprehensive Economic Cooperation Agreement (CECA) signed between India and Singapore is a glowing example of what we can achieve in taking our cooperation to greater heights. Lets us, therefore, make the best of our growing ties and fraternal relations for the mutual benefit of our peoples.





SCIC – SCDF Dialogue Session

A dialogue session with the Singapore Civil Defence Force (SCDF) was organised by the Singapore Chemical Industry Council (SCIC) on Monday, 26 March 2007 with more than 50 participants.

Participants were updated on the following issues by SCDF during the dialogue:

Live Inventory Portal (LIP)

- A debrief session was held on 28 Feb 2007 at HQ SCDF for companies who had participated in the first and second trials of the LIP. The session was mainly to gather participating companies' feedback on improving the userfriendliness of the online LIP information input portal. A summary of the debrief points were presented by SCDF.
- SCDF would engage the industry through dialogues, seminars and training sessions to assist and prepare affected companies prior the introduction of the LIP.
- The LIP would be introduced in the second quarter of 2007.

Implementation of the Hazmat Transport Vehicle Tracking System (HTVTS) Phase II -Immobilization of Hazmat Transport Vehicles

- Through the immobilizer unit installed on all Hazmat Transport Vehicles, SCDF would be able to intervene and stop these vehicles safely and effectively, in the event they are hijacked.
- The implementation of the immobilizer will commence from 1 April 2007 and installation of the immobilizer will coincide with affected companies' renewal of the Flammable Materials (FM) transport license.
- SCIC has since circulated notification letters sent by SCDF to all SCIC members on details of the vendor awarded with the tender in March 2007. Included are also the financial assistance schemes made available by the vendor.

The discussions that followed focused primarily on the views and concerns of the participants on the LIP. SCDF welcomed the feedback which would help further refine the LIP and also encouraged all potential companies to participate in the trials before the system is officially launched.



SCIC Annual Dinner 2007 cum Responsible Care Awards 2006

The Singapore Chemical Industry Council (SCIC) held its Annual Dinner 2007 and Responsible Care Awards 2006 presentation on 22 March 2007 at the Singapore Marriott Hotel.

The event was graced by Mr Gan Kim Yong, Minister of State for Education and Manpower and was attended by more than 370 guests. Invited guests included representatives from various government agencies from the Ministry of Manpower (MOM), Ministry of Trade and Industry (MTI), Economic Development Board (EDB), IE Singapore, JTC Corporation, National Environment Agency (NEA), Singapore Civil Defence Force (SCDF) and SPRING Singapore.

In his keynote address, Mr Gan mentioned the need for the chemical industry to be able to get enough workers to sustain its growth. He indicated that MOM would be working with the industry to help Singaporeans seize job opportunities that will be created as the sector grows. Mr Gan also informed of MOM's recent announcement to adjust foreign manpower policies that will allow more foreign workers in some sectors to supplement the local workforce. Specifically for the process industry, MOM will increase the dependency ratio to 1:5 from the current 1:4 from 1 April 2007 as well as to allow the cross deployment of foreign workers within the industry. On workplace safety and health, Mr Gan commended the industry on its active role in driving the Responsible Care initiative in Singapore and encouraged the industry to continue to maintain its leadership in workplace health and safety standards.

The Responsible Care Awards 2006 presentation segment of the evening saw a total of 56 company awards being presented. This year, the individual award went to Mr Richard Gillis who has been an active participant and

contributor to Responsible Care in Singapore. A Special Recognition award was presented to Mr Leong Kwai Yin from the National Environment Agency who has represented his organisation as a member of the Panel of Judges since the inception of the awards in 2001.

The Workplace Safety and Health Act (WSHA) came into effect on 1st March 2006. Its aim is to reduce risks at source by stipulating that stakeholders are accountable and need to take reasonably practical steps to ensure the safety and health of workers and other people who might be affected.

Jointly organised by Enterprise Development Centre at Singapore Manufacturers' Federation (EDC@SMa) and the Workplace Safety and Health Committee (WSHAC), supported by JTC Corporation and Ministry of Manpower (MOM), there was a series of CEO Briefing on the WSHA and Risk Management Assistance Fund (RMAF) conducted from January to March 2007.

Participants who had attended the briefings found out more about their responsibilities as stakeholders as well as the penalties involved and how they could conform to the new WSHA, and more importantly, reduce the number of industrial accidents in their workplace. Specialist from Risk Management, MOM also shared how the RMAF can help companies to implement risk assessment programmes at their workplaces.


